The Fulbright Programme

The Fulbright programme of international educational exchange was an initiative of American Senator J. William Fulbright from Arkansas, who in the aftermath of World War II believed that mutual understanding between different countries and cultures was crucial to ensure a peaceful future for the world.

The Fulbright Act, an ingenious piece of legislation passed by the United States Congress in 1946, directed proceeds from the sale of surplus war property, foreign loan repayments and reparations to fund the “promotion of international good will through the exchange of students in the fields of education, culture, and science.”

In Senator Fulbright’s own words, the Fulbright programme aims “to bring a little more knowledge, a little more reason and a little more compassion into world affairs and thereby to increase the chance that nations will learn at last to live in peace and friendship.”

New Zealand was the fifth country to sign up to the Fulbright programme by bilateral treaty with the United States of America, in 1948. Since then Fulbright New Zealand has sent more than 1,400 New Zealand graduate students, artists, academics and professionals to the US and welcomed more than 1,100 Americans on exchanges here.

Fulbright New Zealand is jointly funded by the US and New Zealand governments with additional funding from award sponsors, private philanthropists and alumni donors. It is governed by a twelve member Board of Directors comprised of six New Zealanders and six Americans.

The Fulbright programme has been described as one of the largest and most significant movements of scholars across the face of the earth and now operates in over 155 countries, funding around 8,000 exchanges per year for participants to study, research, teach or present their work in another country.

The more than 300,000 Fulbright alumni worldwide include heads of state, cabinet ministers, ambassadors, politicians, judges, heads of corporations, university presidents, journalists, artists, professors and teachers.

Esteemed alumni of the Fulbright programme include Alan MacDiarmid, Dame Marie Clay, Sir Wallace Rowling, Allen Curnow, Dame Jean Herbison, Sir Kenneth Keith, C. K. Stead, Bill Manhire, James Belich, Michael King, Witi Ihimaera, David Cunliffe and many other significant New Zealanders.

Fulbright grantees make the most of their exchanges to get to know and understand a different country and culture, to advance themselves academically or professionally and to make lifelong friendships and professional relationships. Many look back on their Fulbright exchange as a life-changing experience and a defining moment of their career.

Fulbright Student Programme

Fulbright New Zealand offers a range of awards to New Zealand and American graduate students to study or research in each other's countries. Grantees are selected on the basis of academic excellence, leadership potential and ambassadorial qualities.

In addition to award payments towards study or research, all grantees receive return airfares, insurance cover and programme support during their exchange.

International Fulbright Science and Technology Awards

These awards are for promising graduate students from around the world to undertake fully-funded PhD study at top US universities in fields of science, technology or engineering.

Approximately 40 awards with an estimated value over NZ\$350,000 are offered internationally each year to students who are nominated by their home country's Fulbright commission and selected by rigorous international competition.

Fulbright-Ministry of Science and Innovation Graduate Awards

These awards are for promising New Zealand graduate students to undertake postgraduate study or research at US institutions in fields targeted to support growth and innovation in New Zealand.

Approximately 10 awards valued at up to US\$25,000 (plus travel expenses and insurance) are offered each year.

Fulbright New Zealand offers a range of awards to New Zealand and American academics, artists and professionals to research, teach, present their work and gain practical experience in each other's countries.

Scholar awards range from small contributions towards short term visits to fully-funded exchanges of up to one year, including airfares, insurance cover and programme support.

Fulbright New Zealand Senior Scholar Awards

These awards are for New Zealand academics, artists or professionals to lecture and/or conduct research in the US for three to five months.

A small number of awards valued at up to US\$32,500 (plus travel expenses and insurance) are offered each year.



Ian Barber

Ian Barber from Dunedin will research revitalization movements in Māori, Western Pacific and Anglo-American religions, at Brigham Young University in Provo, Utah.

Ian is a Senior Lecturer in Archaeology at the University of Otago.



Chellie Spiller Ngāti Kahungunu

Chellie Spiller from Auckland will research indigenous business models for creating relational wellbeing in addition to wealth, at Harvard University in Cambridge, Massachusetts and the University of Arizona in Tuscon.

Chellie is a Lecturer in Business at University of Auckland.



Yvonne Underhill-Sem Cook Island Māori, Niuean, New Zealander

Yvonne Underhill-Sem from Auckland will research the potential of feminist population geography theories to address maternal mortality, at the City University of New York.

Yvonne is Director of the Centre for Development Studies at the University of Auckland.



Rachael Vernon

Rachael Vernon from Hastings is researching development of a model for assessing continuing competence of nurses, at the University of Washington in Seattle.

Rachael is Head of the School of Nursing at EIT Hawke's Bay.



Gwenda Willis

Gwenda Willis from Wellington is researching American sex offender treatment programmes following the New Zealand-developed Good Lives Model, at Lynn University in Boca Raton, Florida.

Gwenda is a Postdoctoral Fellow at Victoria University of Wellington.

Fulbright Visiting Scholar Awards in New Zealand Studies

These awards are for New Zealand academics to research and teach a course in New Zealand Studies at Georgetown University in Washington, DC for one or two semesters.

Two awards - one per semester - valued at up to US\$32,500 (plus travel expenses and insurance) are offered each year.



Chris Gallavin

Chris Gallavin from Christchurch researched US approaches to judicial oversight of the decision to prosecute, and taught a course on New Zealand's constitutional structure and international relations, at Georgetown University in Washington, DC for their Spring 2011 semester.

Chris is a Senior Lecturer in Law at the University of Canterbury.



David Small

David Small from Christchurch will research the appropriateness of anti-terrorism measures adopted by low risk countries, and teach a course on the transformation of New Zealand society over the past 30 years, at Georgetown University in Washington, DC for their Fall 2011 semester.

David is a Senior Lecturer in Education at the University of Canterbury.

Fulbright-Ngā Pae o Te Māramatanga Senior Scholar Award

This award is for a New Zealand academic, artist or professional to conduct research and/or lecture in the US for three to five months in a field of indigenous development.

One award valued at up to US\$32,500 (plus travel expenses and insurance) is offered each year.



Leonie Pihama Te Atiawa, Ngāti Māhanga, Ngā Māhanga a Tairi

Leonie Pihama from Auckland researched impacts of historical and intergenerational trauma on the health and wellbeing of indigenous peoples, at the University of Washington in Seattle.

Leonie is Director of Māori And Indigenous Analysis Ltd (MAIA).

Fulbright-Cognition Scholar Award in Education Research

This award is for a New Zealand educator or scholar to pursue research in the US designed to have an impact on New Zealand early childhood education or primary/secondary schooling and student achievement, for three to five months.

Usually one award valued at up to US\$32,500 (plus travel expenses and insurance) is offered each year. This year two awards were granted.



Ngaire Addis

Ngaire Addis from Havelock North will research the use of mathematics achievement data in evidence-based leadership of American high schools, at Harvard University in Cambridge, Massachusetts.

Ngaire is a Senior Teacher at Havelock North High School.



Veronica O'Toole

Veronica O'Toole from Christchurch is researching the development of an emotional literacy programme for New Zealand educators and students, at Yale University in New Haven, Connecticut and Wichita State University in Wichita, Kansas.

Veronica is a Lecturer in Adult Education at the University of Canterbury.

Fulbright-Creative New Zealand Pacific Writer's Residency

This award is for a New Zealand writer of Pacific heritage to carry out work on an approved creative writing project exploring Pacific identity, culture or history at the University of Hawai'i for three months.

One residency valued at NZ\$30,000 is offered each year.



Marisa Maepu

Marisa Maepu from Wellington will research and write a novel entitled *Sala ma Sina* at the University of Hawai'i at Mānoa in Honolulu.

Marisa is short-story writer and novelist.

Fulbright-Wallace Arts Trust Award

This award is for an outstanding mid-career or senior New Zealand visual artist to undertake a three-month residency at Headlands Center for the Arts in Sausalito, California.

One residency valued at over US\$30,000 is offered each year.



Mark Braunias

Mark Braunias from Kawhia is completing a three month residency at Headlands Center for the Arts in Sausalito, California.

Mark is a painter, drawer, sculptor and animator, and a Lecturer in Design and Visual Arts at Unitec.

Fulbright-Harkness New Zealand Fellowship

This fellowship is for an emerging New Zealand leader in any field of study or vocation (excluding health care policy and practice) to study or research in the US for a minimum of six weeks.

One fellowship valued at NZ\$15,000 is offered each year.

Fulbright New Zealand Travel Awards

These awards are for New Zealand academics, artists or professionals to visit the US for 12 to 90 days in order to present their work to American audiences.

Approximately twelve awards valued at up to NZ\$5,000 are offered each year.

Hinemoana Baker from Paekakariki performed her poetry and music at the University of Iowa's 43rd annual International Writing Programme in Iowa City.

Hinemoana is a poet and musician, and a Lecturer in Poetry at Whitireia New Zealand.



Lisette Burrows

Lisette Burrows from Dunedin presented a paper entitled *Fat Porkies in School: Governing the healthy child in New Zealand physical education* at the American Education Research Association's 2011 Annual Meeting in New Orleans, Louisiana.

Lisette is an Associate Professor of Physical Education at the University of Otago.

Awards for institutions contribute towards the costs of hosting a visiting specialist.

Fulbright Specialist Awards

These awards are for New Zealand academic institutions to host US academics, artists or professionals for two to six week programmes of lectures, seminars, workshops, conferences or symposiums.

Approximately six awards valued at up to NZ\$8,400 (plus travel expenses) are offered each year.



Diane Campbell

Other Awards and Fellowships

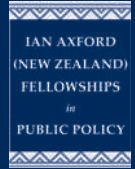
Fulbright New Zealand administers a range of other awards and fellowships for exchange between New Zealand and the US, on behalf of various partner organisations.

These fellowships, offered by the Ian Axford (New Zealand) Fellowships Board and funded by various New Zealand government agencies, are for outstanding mid-career US professionals to research and gain first-hand experience of public policy in New Zealand for seven months.

A small number of fellowships valued at up to NZ\$45,500 (plus travel expenses and insurance) are offered each year.
