The Fulbright Programme

The Fulbright programme of international educational exchange was an initiative of US Senator J. William Fulbright from Arkansas, who in the aftermath of World War II believed that mutual understanding between different countries and cultures was crucial to ensure a peaceful future for the world.

The Fulbright Act, an ingenious piece of legislation passed by the United States Congress in 1946, directed proceeds from the sale of surplus war property, foreign loan repayments and reparations to fund the “promotion of international good will through the exchange of students in the fields of education, culture, and science.”

In Senator Fulbright’s own words, the Fulbright programme aims “to bring a little more knowledge, a little more reason and a little more compassion into world affairs and thereby to increase the chance that nations will learn at last to live in peace and friendship.”

New Zealand was the fifth country to sign up to the Fulbright programme by bilateral treaty with the United States of America, in 1948. Since then Fulbright New Zealand has granted more than 3,000 exchange awards, sending more than 1,600 New Zealand graduate students, artists, academics, teachers and professionals on exchanges to the US and welcoming more than 1,300 Americans on exchanges to New Zealand.

Fulbright New Zealand is jointly funded by the US and New Zealand governments with additional funding from award sponsors, private philanthropists and alumni donors. It is governed by a twelve member Board of Directors comprised of six New Zealanders and six Americans.

The Fulbright programme has been described as one of the largest and most significant movements of scholars across the face of the earth and now operates in over 155 countries, funding around 8,000 exchanges per year for participants to study, research, teach or present their work in another country.

The more than 300,000 Fulbright alumni worldwide include heads of state, cabinet ministers, ambassadors, politicians, judges, heads of corporations, university presidents, journalists, artists, professors and teachers.

Esteemed alumni of the Fulbright programme include Dame Marie Clay, Sir Kenneth Keith, Sir Wallace Rowling, Dame Anne Salmond, David Cunliffe, Gareth Farr, Witi Ihimaera, Michael King, Alan MacDiarmid, Bill Manhire, Ron Paterson, Jan Wright and many other prominent New Zealanders.

Fulbright grantees make the most of their exchanges to get to know and understand a different country and culture, to advance themselves academically or professionally and to make lifelong friendships and professional relationships. Many look back on their Fulbright exchange as a life-changing experience and a defining moment of their career.

Fulbright Student Programme

Fulbright New Zealand offers a range of awards to New Zealand and American graduate students to study or research in each other's countries. Grantees are selected on the basis of academic excellence, leadership potential and ambassadorial qualities.

In addition to award payments towards study or research, all grantees receive return airfares, a basic health benefit plan and programme support during their exchange.

Fulbright-Platinum Triangle Award in Business

This award is for an emerging New Zealand business leader to complete a Master of Business Administration (MBA) degree at a US institution and gain professional work experience in the US and New Zealand.

One award valued at up to US\$75,000 plus a paid internship is offered each year.

Graeme Fielder from Auckland will complete a Master of Business Administration degree, specialising in entrepreneurship, innovation and technology venture growth, at Stanford University in Stanford, California.

Graeme graduated with a BTech (Hons) from the University of Auckland in 2007, and is currently completing a PhD there.

Fulbright Science and Innovation Graduate Awards

These awards are for promising New Zealand graduate students to undertake postgraduate study or research at US institutions in fields targeted to support growth and innovation in New Zealand.

Approximately 10 awards valued at up to US\$33,000 are offered each year. This year 16 awards were granted.

Fulbright Scholar Programme

Fulbright New Zealand offers a range of awards to New Zealand and American academics, artists and professionals to research, teach, present their work and gain practical experience in each other's countries.

Awards range from small contributions towards short term visits to fully-funded exchanges of up to one academic year, including airfares, a basic health benefit plan and programme support.

Fulbright New Zealand Scholar Awards

These awards are for New Zealand academics, artists or professionals to lecture and/or conduct research in the US for three to five months.

A small number of awards valued at up to US\$37,500 are offered each year. This year six awards were granted.



Lisa Emerson

Lisa Emerson from Palmerston North will research the beliefs, attitudes and experiences of scientists as writers over the “lifecycle” of their careers, at the University of Vermont in Burlington.

Lisa is an Associate Professor of English and Media Studies at Massey University Manawatu.



Susy Frankel

Susy Frankel from Wellington will research the application of international treaty interpretation rules and methods to intellectual property law, at New York University.

Susy is a Professor of Law at Victoria University of Wellington.



Barrie Gordon

Barrie Gordon from Wellington will research implementation of the Teaching Personal and Social Responsibility pedagogical model in out-of-school programmes for underserved youth in the US, at North Illinois University in DeKalb.

Barrie is a Senior Lecturer and Curriculum Leader in Health and Physical Education at Victoria University of Wellington.

Fulbright Visiting Scholar Award in New Zealand Studies

Two awards - one per semester - valued at up to US\$37,500 are offered each year. This year one award was granted.



Scott Wilson

Scott Wilson from Auckland researched and taught a course on the development and representation of a national identity in New Zealand cinema, at Georgetown University in Washington, DC for their Spring 2013 semester.

Scott is a Senior Lecturer in Performing and Screen Arts at Unitec Institute of Technology.

Fulbright-Ngā Pae o Te Māramatanga Scholar Awards

These awards are for New Zealand academics, artists or professionals to conduct research and/or lecture in the US for three to five months in a field of indigenous development.

Usually one award valued at up to US\$37,500 is offered each year. This year two awards were granted.



Eruera Tarena Ngāi Tahu, Ngāti Porou, Te Whānau-ā-Apanui

Eruera Tarena from Christchurch is researching the features and mechanisms of contemporary indigenous organisation design, at Arizona State University Tempe in Tempe, Arizona and the University of Hawai'i at Mānoa in Honolulu.

Eruera is Manager of Strategy and Relationships at Te Tapuae o Rēhua.



Veronica Tawhai Ngāti Porou, Ngāti Uepohatu

Veronica Tawhai from Palmerston North researched indigenous political educators' assessments of the transformative potential of citizenship education, at the Center for World Indigenous Studies in Olympia, Washington.

Veronica is a Lecturer in Māori Studies at Massey University Manawatu.

Fulbright-Cognition Scholar Award in Education Research

This award is for a New Zealand educator or researcher to pursue research in the US designed to have an impact on New Zealand early childhood education or primary/secondary schooling and student achievement, for three to five months.

One award valued at up to US\$37,500 is offered each year.



Jenny Langrish

Jenny Langrish from Wanganui is researching the implementation of school-wide positive behaviour support plans in the US, at the University of Missouri-Columbia.

Jenny is Assistant Principal of Wanganui High School.

Fulbright-Creative New Zealand Pacific Writer's Residency

This award is for a New Zealand writer of Pacific heritage to carry out work on an approved creative writing project exploring Pacific identity, culture or history at the University of Hawai'i for three months.

One residency valued at NZ\$30,000 is offered each year.



Leilani Tamu Samoan, Pākehā

Leilani Tamu from Auckland will undertake research for her second book of poetry, *Cultural Diplomacy*, at the University of Hawai'i at Mānoa in Honolulu.

Leilani is a poet, historian and freelance journalist.

Fulbright-Wallace Arts Trust Award

This award is for an outstanding mid-career or senior New Zealand visual artist to undertake a three-month residency at Headlands Center for the Arts in Sausalito, California.

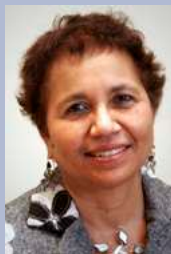

Awards for institutions contribute towards the costs of hosting a visiting scholar.

Fulbright Specialist Awards

These awards are for New Zealand academic institutions to host US academics, artists or professionals for two to six week programmes of lectures, seminars, workshops, conferences or symposiums.

Approximately six awards valued at up to NZ\$11,700 are offered each year. This year nine awards were granted.
