# Celebrating 65 years of Fulbright exchange

Fulbright New Zealand this year celebrates 65 years of educational and cultural exchange between New Zealand and the United States of America. Since the founding of New Zealand's Fulbright commission by bilateral treaty on 14 September 1948, more than 3,000 New Zealanders and Americans have benefited from exchange grants to each other's countries, and have contributed to the success of the two partner nations and mutual understanding between them.

Planning is underway for a programme of activities and events throughout the anniversary year which will be designed to celebrate the auspicious occasion, to raise the profile of Fulbright New Zealand, and to fundraise for additional awards.

Alumni and supporters will be invited to attend expanded annual events in Washington, DC (the reception at the New Zealand Embassy in May) and Wellington (the parliamentary awards ceremony in June). Additional celebrations will be programmed around the anniversary date in September, including black tie gala dinners with art auctions in Auckland and Wellington. Alumni will be invited to contribute works for auction, and all alumni welcomed to attend these grand events and bid for artworks. Proceeds from all events will go towards fundraising efforts for future Fulbright awards.

A significant feature of the 65th anniversary year will be the launch a major fundraising drive with the target of raising NZ\$1.1 million which will be endowed to the Fulbright New Zealand Trust. The interest from such an endowment would fund one additional graduate award per year in perpetuity, and as more funds are added to the trust over time, more awards can be offered. Fulbright alumni, who have themselves experienced the lifechanging benefits of an exchange abroad, are asked to donate or bequest to the endowment as a gesture of their gratitude to the Fulbright programme, allowing additional deserving candidates to follow in their footsteps in future. Fulbright New Zealand's Board of Directors have committed to seeding the endowment with half of the required funds, meaning that NZ\$550,000 will be sought from donors and fundraising events. A fundraising letter and form are included with this newsletter. Secure online donations can be made on the Fulbright New Zealand website, at www.fulbright.org.nz/donate Please donate to help us provide more amazing opportunities.

Throughout the year, Fulbright alumni will be invited to share their stories with Fulbright New Zealand and the wider public. Written reminiscences are sought for publication and/or online use (see Page 7 of this newsletter for details), and alumni will be engaged in media campaigns to share their stories with the general public through mainstream and specialist media.

The Fulbright New Zealand Alumni Association will hold its own events to mark the anniversary, including a nationwide Alumni Week from 8 to 15 September during which events will be held in each of six New Zealand regions. Alumni speakers and audiences will be engaged in events throughout the year including Fulbright Reflections panel discussions, Thought Leaders salons and Fulbright Lectures.

The Board and staff of Fulbright New Zealand hope that grantees, alumni, stakeholders and supporters can join us in marking this milestone, celebrating the remarkable achievements of the programme to date, and contributing to its healthy future. Volunteers are welcomed to assist with the planning and execution of anniversary events and campaigns. ►

# From the desk of the Executive Director

Happy New Year! We hope you had enjoyable holidays and are getting into the swing of things for 2013. We certainly are, especially with it being our 65th Anniversary!

We look forward to celebrating our 65th anniversary in a variety of ways throughout the year and to use the auspicious occasion to galvanise the support of our alumni and friends. We sincerely hope that you attend events and donate money (and artworks) to help grow the endowment to fund additional awards in perpetuity. It really is time that more alumni started giving back to the programme that provided them with many positive experiences and benefits.

There were a number of things that have occurred in the period since our November newsletter. Looking ahead, we are preparing to host the incoming American grantees and their families at orientation in early February. This year is a transitional one for our New Zealand scholar award programmes as we move the closing dates for many of our awards to a new cycle. We encourage even those of you who are familiar with our awards schedule to review this year's closing dates on page 8 of the newsletter – some scholar awards will be offered on two dates in this transitional year.

In March our outreach to New Zealand tertiary education institutions begins with drop-in sessions hosted by Campus Advisors, a new addition to the traditional Outreach Tour which begins in May. We will also trial online outreach in 2013. In April I will attend the Fulbright East Asia and Pacific Regional Meeting in Taipei, Taiwan where we will discuss Fulbright priorities and common challenges, and share best practices.

# US Ambassador hosts grantees and alumni

The US Ambassador to New Zealand, Hon David Huebner, and his spouse Dr Duane McWaine, generously hosted Fulbright grantees, alumni, staff and Board members for two functions at their Lower Hutt residence Camperdown in November.

On 13 November a cocktail function was held for 44 guests including New Zealand graduate students selected for Fulbright exchanges in 2013 and local members of the Fulbright New Zealand Alumni Association. It is hoped that this opportunity for newlyselected grantees to meet one another, Fulbright alumni and the US Ambassador will be repeated annually.

On 22 November, Ambassador Huebner and Dr McWaine hosted a party of 19 Fulbright guests for Thanksgiving dinner, including 2012 Fulbright US Graduate Students, staff and Board members. As is customary, the Fulbright group shared a delightful meal with the Ambassador's extended family, US Embassy staff and locally-serving US Marines. Earlier in the day, the year's seven remaining Fulbright US Graduate Students gave final end-of-year reports to each other and the Fulbright New Zealand staff. ▶

# Survey provides valuable alumni feedback

Fulbright New Zealand's comprehensive survey of alumni in October-November 2012 has provided valuable and encouraging feedback on the impacts and benefits of Fulbright exchanges, and helpful direction for the ongoing engagement of grantees and alumni. 330 Fulbright alumni completed the online survey in the month-long period it was open, and initial analysis indicates strong benefits from the programme and willingness among alumni to remain engaged and give back in various ways.

Of those who responded, 99.4% thought their Fulbright exchange was a worthwhile experience, with 86.5% describing the experience as *life-changing*. 97.2% reported that their Fulbright exchange gave them a greater understanding of their host country and its people, and a similar number agreed that their Fulbright exchange had contributed to the programme's aim of promoting mutual understanding. 95.4% thought their Fulbright exchange has improved their knowledge and skills, and 77.6% thought their exchange had improved

leadership qualities and skills.

In terms of ongoing engagement, 90.6% of the surveyed alumni said they are kept up-to-date with the Fulbright programme, and 78.2% are committed to remaining engaged and giving back. There is high awareness of the Fulbright New Zealand Alumni Association (86.5%), and the 50.5% of alumni saying they are likely to join indicates there is plenty of room for further growth in membership. Awareness of fundraising for further awards is low (as has been the level of activity in recent years), but the high number of alumni indicating a willingness to donate bodes well for this year's major fundraising drive.

Results will be examined in greater detail over coming months. In order to build a more comprehensive data set for further analysis, the online survey has been re-opened for Fulbright alumni who were not able to complete it before last year's deadline. 

Significant progress is reported in the first year working under a new five year strategic plan, which was developed by Fulbright New Zealand's Board of Directors during the year under review.

of grantee diversity, income sources and grant expenditure, and a dedicated page acknowledging our various funders, sponsors and donors.

As always, readers can find out about the year's various award selections, grantees, events and activities. In the year under review (FY2012: 1 October 2011 -30 September 2012), 78 grantees commenced Fulbright exchanges and 79 new grantees were selected for future exchanges. Reports written by nine of the year's Fulbright grantees about their exchange experiences are included in the Annual Report, and some of the many other grantee reports which were submitted but could not be included due to space limitations include are printed in this newsletter – see Page 7.

## Alumni News

Two Hawaiian Fulbright alumni, 'Umi Perkins (2004 Fulbright-Hays Seminar Abroad) and Brandy Nālani McDougall (2001 US Graduate Student) were among speakers at the inaugural TEDxMānoa event held at the University of Hawai'i's Mānoa campus in October. Brandy shared poems and mo'olelo (stories) on the event's theme of 'New Old Wisdom', and 'Umi talked about his six year project to write a new high school history textbook – *Mo'olelo: A Hawaiian History*. Fulbright alumna Clemency Montelle (1999 NZ Graduate Student) from the University of Canterbury was awarded an NZ\$800,000 Rutherford Discovery Fellowship in November, to research the history of mathematics, astronomy and science in India. Clemency will examine ancient manuscripts spanning almost 3,000 years to discover India's intellectual contributions to science. She was one of ten top early/mid-career researchers awarded 2012 Rutherford Discovery Fellowships by the Royal Society of New Zealand.

Fulbright alumnus Rob Goldblatt (1985 NZ Research Scholar) from Victoria University of Wellington was recognised with one of the Royal Society of New Zealand's fourteen 2012 Research Honours in November. Rob was awarded the Jones Medal for lifetime achievements in mathematical sciences, for his profound and world-leading research in modal logic and category theory, and his lifetime of dedicated service to mathematics. The Jones Medal is awarded biennially, accompanied by a prize of NZ\$5,000 awarded by the New Zealand Mathematics Research Institute.

Fulbright alumnus James Russell (2006 NZ Travel Award) was awarded the Prime Minister's MacDiarmid Emerging Scientist Prize in November, one of five Prime Minister's prizes awarded annually. James was recognised for his innovative combination of ecology, statistics and genetics to prevent rats and other mammalian pests invading predator-free islands. Valued at NZ\$200,000, the Prime Minister's MacDiarmid Emerging Scientist Prize is named in honour of Nobel Prize-winning Fulbright alumnus Alan MacDiarmid (1950 NZ Graduate Student) and is awarded to an outstanding

emerging scientist who is working towards a PhD or has completed their PhD within the past five years.

Fulbright alumnus Vince Neall (1979 NZ Research Scholar) from Massey University was recognised in the 2013 New Years Honours List. One of New Zealand's leading experts on volcanoes, Vince was appointed a Member of the New Zealand Order of Merit for services to Earth science.

Fulbright alumna Christina Hulbe (2009 US Senior Scholar) will return to her host institution the University of Otago in February, having been appointed as the university's new Professor and Dean of Surveying. A leading American glaciologist, Christina researches the physical processes underlying observed changes in glaciers and polar ice sheets. She looks forward to advancing her own research and taking part in New Zealand's growing Antarctic research endeavour.

Fulbright alumna Lesley Wheeler (2011 US Scholar Award) from Washington and Lee University has coedited a portfolio of New Zealand poetry for the next issue of the university's literary journal *Shenandoah*. Lesley and two student co-editors have chosen 25 poems from among about 500 works by 103 New Zealand poets. The journal will be published online by the end of February at www.shenandoahliterary.org

# Taking chemistry out of the laboratory

Katy Orr from Reno, Nevada, was one of ten American graduate students who received Fulbright awards to study or research in New Zealand last year. Alongside her research into the deposition of polycyclic hydrocarbons in Arthur's Pass National Park, conducted at the University of Otago, Katy involved herself in some rewarding local science outreach initiatives.

My Fulbright research began on a warm March day in the Waimakariri valley, fervently (but oh so carefully!) collecting bunches of lichen off matagouri bushes as rain clouds approached. An adventure in a pristine national park of New Zealand was a great way to start my environmental chemistry research project. My research parameters are simple; I am looking at the long-range transport of the contaminants produced by car emissions up valleys near a highway. Arthur's Pass National Park has three valleys that extend perpendicularly off of State Highway 73. Knowing that lichen acts as a sponge for contaminants, my advisor Dr Kim Hageman suggested that I collect samples at 1km intervals up each valley for analysis in her lab at the University of Otago. The months that followed those few awesome days of tramping with Kim and my labmate, Cleo Davie-Martin, were occupied with extracting contaminants from the lichen samples.

To break up the lab work I became involved in the university's Chemistry Outreach Programme directed by Dr Dave Warren, which supports the science curriculum of nearby schools. Over the four years that the programme has been running, more and more interest has been generated in the community. It was serendipitous timing that Waitahuna Primary School was looking for a few chemists to set up regular visits to their school and my lab-mate, Trudy Geoghegan, who had participated in outreach for three years, was ready to take the lead in such a partnership. It was an ideal collaboration: we are environmental chemists whose primary focus is environmental monitoring, and the participating students were 11 children who all lived on nearby farms. The children were all keen to explore the world around them and were thrilled to take on projects that revolved around environmental testing.

On visits to the school every two weeks for a period of four months, we would make small steps towards teaching kids the fundamentals of scientific investigation. The plan was to guide these kids, who ranged in age from 8 to 11 years, to think up an original project, devise a way to test their hypothesis, plan a trip and learn methods for gathering their samples, extract and analyze their data and finally present their results to their parents and the larger Waitahuna community.

Having never done this kind of thing before, we were all a little curious as to whether we would be asking too much of the kids. The university lent a water testing kit to Waitahuna School, with which we could test the temperature, pH, nitrate and phosphate content of water. After a few lessons about scientific method and fair testing, we were blown away by the kids' ability to take on the challenge of testing the parameters of water. They definitely exceeded our expectations.

The key to this whole concept was getting the children to come up with their own ideas of what they wanted to measure in the pastures around their communities. Their imaginations ran wild with possibilities, and during brainstorming sessions we helped each group formulate a testable hypothesis. One group in particular, lead by Cleo, named themselves "The Cow Pat Group" and were interested in the nitrate content of soil underneath, beside and near a cow patty.

The students completed sampling, extraction, measurement and analysis (including graphing and statistics!) of the nitrogen content, pH level and temperature of samples. They did a great job with each of the steps and always greeted us enthusiastically, with "the scientists are here!", when we arrived at the school for a lesson. Though only a few of these kids will pursue a career in science, they benefited from learning the scientific process as it should be experienced: a self-directed investigation of the natural world where the results are important and your work is taken seriously. Of course we had a little fun while we were at it.

I have found in my time here in New Zealand that these types of programmes are easily instigated and enthusiastically accepted by the community. The Fulbright US Graduate Students in Otago spent four weeks teaching mini science lessons at Ravensbourne Primary School, a project conceived by Laura Bergner, who has a passion for science communication.

I've been offered support from the university here to complete a PhD in Chemistry, and I feel like I have landed on my feet here in New Zealand. I have never felt so embraced by a community as I have in this short year. Just as my small role in the outreach programme has had a significant impact on the lives of the kids at Waitahuna, the people I have met here through my Fulbright scholarship have had a huge impact on my life's direction. I would like to thank Fulbright New Zealand for their support and for giving me this incredible opportunity. **▷**

### **Alumni Voices**

The following reports were submitted for the 2012 Fulbright New Zealand Annual Report by some of our newest alumni, but were unable to be included due to space restrictions. Amanda Lee from Christchurch received a 2012 Fulbright-Ministry of Science and Innovation Graduate Award to research conversational language and verbal avoidance behaviours in adults who stutter, at the University of Iowa in Iowa City, towards a PhD from the University of Canterbury.

I went to the University of Iowa on a Fulbright exchange to develop my understanding of stuttering theories, and enhance my clinical skills in stuttering treatment. Iowa is the birthplace of stuttering research, and I loved being able to experience firsthand the rich historical influence of the pioneering thinkers in my field, and to work and learn alongside the leading experts of today! I was struck both by the depth and breadth of the knowledge I have encountered – knowledge that is based on sound research evidence, has clear clinical relevance, and is paired with a very real consideration for the overall good of the person who stutters.

My Fulbright experience was also amazing for the opportunities it gave me to meet people, travel and explore the US. I saw fireworks from under the St. Louis Gateway Arch, visited the famous Mall of America in Minneapolis, took a hot air balloon flight over Seattle, and sampled a large number of sugary drinks at Atlanta's World of Coca-Cola! Most importantly, I formed many beautiful friendships. Having recently returned home to continue my doctoral studies at the University of Canterbury, I look forward to welcoming visitors to New Zealand in the near future!

Jennifer Curtin from the University of Auckland received a 2012 Fulbright New Zealand Scholar Award to research career pathways of women politicians in Westminster countries and the US, at Georgetown University in Washington, DC.

My Fulbright project focused on women's pathways to political power in the Anglo-American world. While at Georgetown University in Washington, DC I built a data set of women's political careers in Congress since 1992. I reviewed the various leadership pathways existent in the US House of Representatives and Senate and examined how women negotiate their roles as committee members and with their constituents. I met experts from universities and non-government agencies, who were extremely generous with their knowledge and time. I gave talks to students at Georgetown and Rutgers and at a University of Auckland Alumni function in New York. My time in the US overlapped with the presidential election – nirvana for anyone interested in politics – so I wrote seven articles on that topic for New Zealand's Sunday Star-Times newspaper. And the election result had a direct bearing on my project, with a record number of women (20) now in the Senate.

But equally valuable was the opportunity to absorb American culture and expand my networks. My family and I travelled to other states, attended local sporting events and festivals, and shared Halloween and Thanksgiving with American families. As a result, I now have a deeper understanding of how US politics and society intersect and this knowledge will serve to enhance my future research and teaching on comparative politics and political leadership. **>**
