GENERAL GUIDELINES/CHECKLIST

Applications must be typed using a font no smaller than Times New Roman 10 point and all documents must be included in a single PDF file.
Ensure that all required sections of the application are completed.
Include a CV of no more than four pages.
Include a scan of the photo page of your passport.
Include a letter of invitation from a potential host organisation in the US.
Include a short statement about any previous experience in the US.
Include a statement from your Chief Executive (or the appropriate Deputy Chief Executive or equivalent at the institution or organisation where you are currently employed). The statement should also indicate the organisation's support for your application. This can be included in, or supplementary to, your three references.
Include a one page project statement The proposed project should contribute to the development of knowledge in your respective field. The Project Statement should clearly define the aims of the project, the methodology, and the importance of the project, for the field, for New Zealand and for your own professional development.
Your three referees have been notified to email kyla@fulbright.org.nz directly. Please see guidelines for reference writing on page eight of this application form.
The deadline for the receipt of applications is 5:00pm, 14 October 2017.

If pertinent, it is a J1 visa condition of appointment that Fellows may not seek permanent employment or residence in the US for at least two years following their Fellowships.

- 2) the applicant's professional qualifications and accomplishments;
- 3) what the referee would see as their strengths and weaknesses;
- 4) the calibre of the applicant's work and potential for contribution to their field and proposed study topic;
- 5) any particular qualifications, experiences or reasons why the applicant should be selected to be a New Zealand Harkness Fellow;
- 6) the applicant's leadership potential;
- 7) the suitability of the candidate's proposed programme in the US.
